### \* What is GDPR?

The GDPR is the EU Regulation that will replace the Data Protection Act 1998 in the UK and the equivalent legislation across the EU Member States.

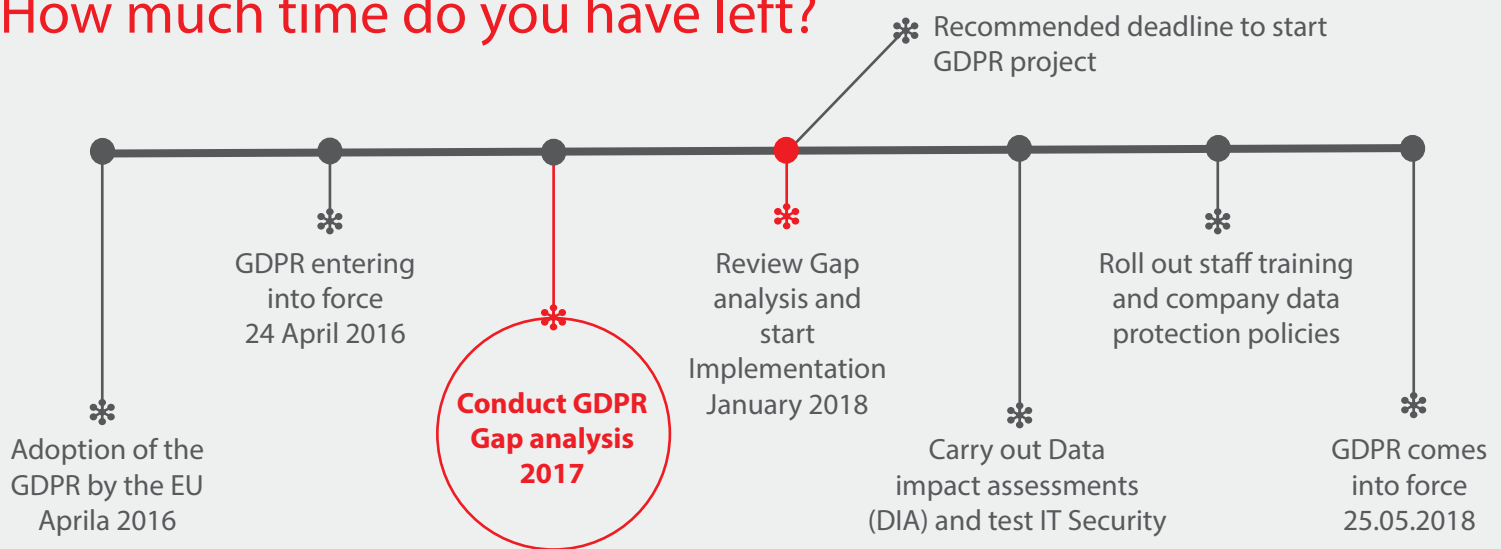
**All UK businesses will be subject to GDPR from 25th May 2018**, regardless of Brexit. Failure to comply could cost you fines of up to 4% of your company's global annual turnover, not to mention your reputation.

Failure to meet the legal requirements under GDPR may result in heavy fines from the (ICO) Information Commissioners Office (up to 4% of turnover) and damage your reputation.

### \* What are the main obligations under GDPR?

- You will need to keep records of your data processing activities
- You may need to designate a Data Protection Officer (DPO)
- Prevent accidental loss or theft of data
- Introduce data encryption
- Prevent un-authorized access to personal data
- Ensure the data you hold is kept up to date
- Make data available to data subjects within 28 days
- Data must be portable in a readable format
- Your IT systems will need to be robust and secure
- You will need to test IT systems and security safeguards
- Provide staff training and awareness
- Conduct Data Audits and map data flows
- Ensure that suppliers who process data on your behalf meet GDPR legislation
